This contract includes the use of facilities listed above. It does not prohibit the general public from use of the playground equipment.

Park Rules

1. Curfew - 11:00 p.m. on all weekday activities, 12:00 midnight for private parties and 1:00 a.m. on weekends.
2. No motor vehicles allowed in the park except on designated parking areas.
3. If amplifiers are used, they should be facing away from the residential area. There are electrical outlets available at the beach pavilion only. No electric is available at Aurelian Springs Park.
5. Grounds must be picked up and trash put into barrels or dumpsters.
6. If tarps are used, they must be folded and put away. Contact Village Hall if you think you may want the tarps.
7. No alcohol is allowed at the Beach, only under the pavilion.
8. No pets are allowed in the Beach area. Pets are allowed at Aurelian Springs Park but must be on a leash and any waste must be cleaned up.
9. There will be no lifeguard on duty, and you will be swimming at your own risk at the beach.
10. Please make sure the garbage cans and picnic tables are under the pavilion.

ANYONE DAMAGING THE FACILITIES WILL BE HELD RESPONSIBLE - VIOLATION OF RULES MEANS FORFEITURE OF TOTAL DEPOSIT.
